GENERAL TERMS & CONDITIONS

TRAVEL DOCUMENTS

All participants must be in possession of a passport for over 6 months from date of travel. Visas may be required for the countries visited on your tour. Visa requirements will be advised at the time of booking.

SPECIAL PERMITS

Participants visiting restricted areas in India like Sikkim, Assam, the North Eastern states, Andaman and Lakshadweep islands.

HEALTH REQUIREMENTS

RANGOLI TOURS PVT. LTD. strongly recommends the tourists to consult public health services of the corresponding country or their physicians for their recommendation.

RESERVATION AND DEPOSITS

Early reservations are essential to ensure proper documentation and guaranteed accommodations. A deposit of 25% of the total bill amount is due at **RANGOLI TOURS PVT.LTD.** office within 15 days after booking, to continue to hold a reservation or as advised by the reservation agent. Final payment is due to **RANGOLI TOURS PVT.LTD.** 60 days prior to departure. Reservations received within 45 days of departure require full payment at the time of confirmation or as specified by the reservation agent. All rates shown are in United States Dollars or Euro and are accurate at the time of publication. Rates are subject to change at any time prior to tour departure.

TOUR INFORMATION

A booking acknowledgement will be sent immediately upon receipt of a reservation. An invoice with appropriate visa applications and general information reading and clothing suggestions, customs information, weather etc on the countries visited will be forwarded upon receipt of deposit. Final tour documents consisting of detailed tour itinerary, hotel list, mailing list, tour member list etc. are forwarded approximately 30 to 45 days prior to the start of the tour departure.

CANCELLATION AND CHANGES

Cancellation received 45 to 30 days prior to arrival in India 50%, 30 to 15 days 75%, less than 15 days 100% of the total cost will be charged. To protect against cancellation charges, we strongly recommend purchasing cancellation protection and travel interruption insurance No refund will be made for any unused accommodation and / or missed meals, sightseeing tours or unused services of chartered transportation. **RANGOLI TOURS PVT.LTD.** reserves the right to cancel any individual membership in its entirety or part thereof by refunding a proportionate balance for the unused portion of the tour. All cancellations must be received in writing by **RANGOLI TOURS PVT.LTD.**. Refunds will be calculated from the date the cancellation is received by **RANGOLI TOURS PVT.LTD.**. No claims will be considered after 15 days from the termination of the tour.
